### Potential Health Effects

#### Inhalation:

## 4. First Aid Measures

**Inhalation:**

Remove to fresh air. Get medical attention for any breathing difficulty.

**Ingestion:**

Induce vomiting immediately as directed by medical personnel. Never give anything by mouth to an unconscious person. Call a physician.

**Skin Contact:**

Immediately flush skin with plenty of water for at least 15 minutes. Call a physician if irritation develops.

**Eye Contact:**

In case of contact, immediately flush eyes with plenty of water for at least 15 minutes, lifting upper and lower eyelids occasionally. Call a physician if irritation persists.

## 5. Fire Fighting Measures

**Fire:**

Flash point: 250°C (482°F) CC

As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source. Burns when exposed to heat or flame.

**Explosion:**

Fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Above the flash point, explosive vapor-air mixtures may be formed. Sensitive to mechanical impact. Sensitive to static discharge.

**Fire Extinguishing Media:**

Water spray, dry chemical, alcohol foam, or carbon dioxide. Apply cooling water until well after fire is out.

**Special Information:**

## 6. Accidental Release Measures

Spills: Clean up spills in a manner that does not disperse dust into the air. Use non-sparking tools and equipment. Reduce airborne dust and prevent scattering by moistening with water. Pick up spill for recovery or disposal and place in a closed container.

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Isolate from any source of heat or ignition. Isolate from oxidizing materials.

### **Airborne Exposure Limits:**

### **Ventilation System:**
